

**Preparation of Cadastral Maps and Plans by Registered Licensed Surveyor
Under Title Registration Act No 21 of 1998**

AGREEMENT

THIS AGREEMENT is made on the(Date) between Senior Superintendent Of Surveys -District on behalf of The Surveyor General , Surveyor General's Office, Kirula Road, Narahenpita hereinafter called "The Employer" of the one part and

WHEREAS the Employer desirous that the work known as Cadastral Surveys of Survey Requisition No, Cadastral Map Number, Block Number should be executed by the Surveyor and Surveyor accepted the Prices by the Employer for the execution and completion of such work and remedying of any defect therein.

NOW THIS AGREEMENT WITNESEETH as follows

01. In this agreement words and expressions shall have the same meaning as respectively assigned to them in the Contract Document referred to.
02. The following documents shall be deemed to form and be read and concurrence of this agreement
 - a. This form of Agreement
 - b. The Application submitted by the surveyor
 - c. Employer's Notification of award
 - d. The letter of Acceptance
 - e. Terms and condition document
 - f. Qualifications and Instructions document
 - g. Survey Requisition
 - h. Departmental Survey Regulations and State Land Mark Ordinance
03. The aforesaid documents shall be taken as complementary and mutually explanatory of one another, but in the case of ambiguities or discrepancies shall take precedence in the order set out above.

04. In consideration of the payment to be made by the Employer to the Surveyor as indicated in this Agreement, the Surveyor hereby covenants with the Employer to execute and complete the Work in conformity in all respects the provisions of the Contract.
05. This agreement shall be in force from the date of this agreement is signed.
06. The Employer hereby covenants to pay the Surveyor in consideration of the provision of the services and the remedying of any defects/omissions therein, the contract price of such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.
07. The surveyor agrees to complete Cadastral Map of said block before
(date of completion according to condition document) However the Surveyor can ask for extension due to reasons beyond his own faults from the Employer before the agreed date of completion.
08. The surveyor agrees and understands that penalty for any delays exceeding time period as per clause 7 will be surcharged on him by the employer.
