To the persons who are subjected to Declaration of Assets and Liabilities in terms of section 80(1) of the Anti-Corruption Act, No. 9 of 2023 and to the Heads of the respective Institutions to whom the Declaration is to be submitted.

Declaration of Assets and Liabilities in terms of Anti-Corruption Act, No. 9 of 2023

The Declaration of Assets and Liabilities Law, No. 1 of 1975 has been repealed by the Anti-Corruption Act, No. 9 of 2023 (Anti-Corruption Act) and Section 79 to Section 92 of the Anti-Corruption Act stipulates the legal provisions pertaining to Declaration of Assets and Liabilities.

- 2. Accordingly, the Commission to Investigate Allegations of Bribery or Corruption (the Commission) as the Central Authority on Declaration of Assets and Liabilities is vested with the obligation of installing a Centralized Electronic System (CES), facilitating the receipt and verification of the Declarations of Asset and Liabilities.
- 3. Currently, steps are being taken by the Commission to install the CES as required by the Anti-Corruption Act and until such time the installation of the CES is completed, the Commission hereby directs all the heads of respective institutions to whom the Declarations were submitted under the provisions of the previous Law before the enactment of the Anti-Corruption Act, to receive and retain the Declarations of Assets and Liabilities on behalf of the Commission as per the Format in Annexure I.
- 4. The persons subjected to Declaration of Assets and Liabilities in terms of Section 80(1) of the Anti-Corruption Act are listed in the *Column I* of **Annexure II**. The persons to whom the Declaration is to be submitted are listed in the *Column II* of **Annexure II**.
- 5. The persons to whom the Declarations are to be submitted as specified in *Column II* of **Annexure II** shall consider the following:—
 - (i) Declarations shall be received in a manner securing the confidentiality of the same and shall be kept in safe custody;

(ii) Declarations shall be accepted within the prescribed period as specified in Annexure III as per Section 82 of the Act;

(iii) Appropriate measures shall be adopted to acknowledge the receipt of the Declaration;

(iv) Maintain an updated register on the submission of Declarations and submit a list of Declarants, who had and who had not submitted the Declaration during the prescribed period, to the Commission immediately after the due date;

(v) Prevent any access to the Declaration by any person following the submission of the Declaration to the head of the respective institutions, except with the sanction of the Commission;

(vi) Upon a request of the Commission, it shall be the responsibility of the respective persons who is entrusted with the custody of the Declaration to immediately make available the same to the Commission without delay; and

(vii) The format of the Declaration is available for download in the official web site of the Commission, www.ciaboc.gov.lk in Sinhala, Tamil and English Languages, and the submission of the same can be made in any of the said three languages.

- (b) the assets and liabilities of his spouse;
- (c) the assets and liabilities of each of his dependent children irrespective of their age;
- (d) assets and liabilities of any other person's dependent on him irrespective of their age; and
- (e) the assets and liabilities of any other person who cohabits and shares the common household with the person to whom this part applies for at least six months prior to the date of declaration except where such person does not share mutual rights and obligations with person to whom this part applies.

When to make declarations of assets and liabilities

1) At the first appointment Within the three months

2) After the appointment Annually

3) Retirement or End of tenure Within 14 days

4) After retirement Annually for two consecutive years

5) Acquisition exceeding Rs. 10 Million Within one month

6) Election candidates Along with nomination papers

7) Persons not included in 01-06 above, but require to make declaration of assets and liabilities in terms of other Laws shall declare the assets and liabilities adhering to the provisions of the respective Laws.

- **82.** (1) every person to whom this Part applies shall, in the form as may be prescribed by regulations make declarations of assets and liabilities-
- (a) Within three months of the date of appointment (hereinafter referred to as the "first appointment declaration");
- (b) Annually in terms of subsection (3) (hereinafter referred to as the "annual declaration");
- (c) within a period of fourteen days immediately after the end of the tenure of his employment or the date of his retirement or the date of dismissal from office as the case may be (hereinafter referred to as the "end of tenure or retirement declaration");
- (d) In two consecutive years immediately succeeding the year of making the declaration under paragraph (c) (hereinafter referred to as the "post retirement declaration");
- (e) where a significant change in the value of assets and liabilities amounting to ten million rupees or more than ten million rupees occurs, within one month from the date of such occurrence (hereinafter referred to as the "ad-hoc declaration"); and

- (f) When nomination papers are submitted for elections, under the Presidential Elections Act, No. 15 of 1981, the Parliamentary Elections Act, No. 1 of 1981, the Provincial Councils Elections Act, No. 2 of 1988 or the Local Authorities Elections Ordinance (Chapter 262) as the case may be.
- (2) Where a person who on the appointed date is not a person to whom this Part applies, he shall, within three months of the date on which he becomes a person to whom this Part applies, make a declaration of assets and liabilities as at the date such person becomes a person to whom this Act applies: Provided that, a person to whom this Part applies as is referred to in paragraph (w) of subsection (1) of section 80 shall submit his declaration for the period up to the date of the declaration made under the relevant law declaring the date of election.
- (3) Every person who is required to make the first declaration of assets and liabilities under subsection (1) or (2) shall, unless such person ceases to be a person to whom this Part applies, by the thirtieth day of June in each year, make in the Form as may be prescribed by regulations a declaration of his assets and liabilities as at the thirty first day of March of such year and include in such declaration the assets and liabilities he held on the date on which he was first required to make a declaration of his assets and liabilities under this Part: Provided that, where a person who is required to make a declaration of assets and liabilities under subsection (2) has made the first declaration as at any date within six months preceding the thirty first day of March in any year, he shall not be required to make another declaration for such year other than an ad-hoc declaration where a significant change referred to in paragraph (e) of subsection (1) occurs in his assets and liabilities.
